Kursets hovedmålsetting er å gi forståelse for dannelsen og utviklingen av Den europeiske union. Dette gjøres gjennom å studere betingelsene for integrasjon på tre ulike plan: det innenrikspolitiske, det europeiske og det internasjonale. Kurset setter ideen om et forent Europa i et langt historisk perspektiv, men har sitt hovedfokus på perioden etter 2.verdenskrig.
